Your site application will be considered in receipt of a completed Application Form including payment and all requirements detailed below are met. Applications close on 20th September 2024.

Please note the earlier we receive your 2024 application, the quicker we can confirm your site and limit the number of same type vendors attending. That way everyone wins on the day.

Public Liability Insurance:

- Please note that a COPY of your Public Liability Policy or a Certificate of Currency will need to be provided for the period of the Show, and should also be supplied with your application, up to \$20 million. This applies to Commercial/Business stall holders.
- An additional sum of \$20.00 (Administration Fee) is payable for hobbyist stall holders.

Site Charges: \$5.00 per metre frontage – minimum charge \$30.00 (includes one entry)

Camping: Free but limited at showgrounds. Sites – available at the Berrigan Caravan Park - \$.POA per night – bookings contact Berrigan Caravan Park – 0400 563 979

Food Safety: All food outlets must comply with government health regulations and have the relevant documentation for Show Day. An inspection by a show representative will occur on the day of the Show.

Banned Items: A list of Banned Items is on a separate sheet and will be strictly adhered to.

LIST OF BANNED ITEMS 2023 – 2024

The Victorian Showmen's Guild and Victorian Agricultural Shows Ltd have agreed that the following items are banned at Agricultural Shows.

It is our view and aim to protect and attract families to the Local Shows.

- Explicit and Hardcore T-Shirts
- Explicit DVDs and Videos
- Fake Cigarettes
- Fuel Type Fire Lighters (Zippo)
- Iridescent Hair Spray
- Trumpets
- Knives (including Pen Knives) excluding appropriately packaged kitchenware sets
- Metal and Wooden Martial Art Nunchakus
- Laser Pen Lights and / or Laser Toys
- Playing Cards (Nude or Lewd)
- Pressure Pack Fart Gas
- Pressure Pack Snow
- Pressure Pack Silly String
- Drug Related Goods (including Cocaine Kits, Bongs, etc.)
- Stink Bombs
- Water Pistols longer than 150mm
- Water Bombs

Toy Guns are acceptable however the following are NOT allowed:

- Guns that are designed to Project any form of Object or Projectile
- Pellet Guns
- Ball Bearing Guns
- Replica Guns (Bullet Type)
- Pop Downs (Throw Downs)
- 8 Shot Caps (caps only banned)
- Strip Caps (caps only banned)
- Roll Caps (caps only banned)
- Fireworks or Crackers

WAIVER & INDEMNITY

- 1.1 The exhibitor acknowledges and agrees that the exhibitor will display its goods products or services at the Show entirely at the exhibitor’s own risk and the Show Society will not be liable in respect of any loss or damage to the exhibitor’s goods etc as a consequence of the exhibitor exhibiting at the Show including, without limiting the generality of this waiver, loss or damage caused by the negligence of the Show Society or its officers, employees or agents.
- 1.2 The exhibitor indemnifies the Show Society against any liability or loss arising from, and any costs charges or expenses incurred in connection with:
 - (a) Any loss or damage to any property belonging to the Show Society or others; and/or
 - (b) Injury or death of any person caused by the negligent act or default of the exhibitor or any of the exhibitor’s employees or agents.

INSURANCE DECLARATION:

a) For Business/Commercial Stall Holders: Defined as those who are a commercial enterprise and have an ABN. These stall holders **must have their own insurance policy** with a minimum \$20M Public Liability cover and provide a copy of their certificate of currency to the Show. They cannot access the Show’s public liability insurance in any manner.

b) For Hobbyist Stall Holders: Defined as those who are not running a formal commercial enterprise nor have an ABN and they earn under \$20,000 per year from their stall activity. Those Hobbyist Stall Holders who meet this definition and have signed the below declaration are automatically covered under the Show’s insurance cover for Public Liability. The ASC’s Public Liability insurance does not extend to Hobbyists in any manner for any Products Liability exposure.

I declare that I am a Hobbyist Stall Holder, do not have an ABN and do not earn more than \$20,000 in this enterprise on an annual basis. I am therefore protected under the Show’s Liability policy for Public Liability only. I am aware that this protection does not extend to Products Liability.
